

CH9 STATEMENT OURSES OF ACTION

ANSWERS AND EXPLANATIONS

- (d) Money is very important for the execution of any plan. Reduction in other expenditures will definitely help to raise money. Hence I follows. Any programme can not succeed without a good planning. Hence II follows.
- (d) I is advisable because it will prepare the farmer to face the situation (in a better way) well in advance. II is also advisable because it will be helpful to cope with the problem related to water.
- (a) Clearly, such projects shall be an asset and a source of income to the country later on. So, course I shall follow.
- 4. (d) Since severe damage has been caused by cyclone, people in affected villages ought to be shifted to safer places. Also, since relief work entails huge amounts, financial help from Central Government is a must. So, both the courses follow.
- 5. (a) The effectiveness of such Control Boards is established by the fact that Orissa and A.P. have agreed to it for better control of its multipurpose projects. So, only course I follows.
- 6. (c) The problem pointed out in the statement is the over crowdeness of the footpaths, which are meant for the pedestrians. So the problem must be either lessened or completely solved for any of the courses to follow. I follows as this will completely solve the problem. II can also solve the problem as the pedestrians can move easily. Hence either of I or II follows.
- 7. (d) Clearly, the two diseases mentioned are caused by unhygienic conditions. So, improving the hygienic conditions is a step towards their eradication. Also, constant medication will help timely detection of the disease and hence a proper treatment. So, both I and II follow.
- 8. (d) I is advisable because partial cut in supply will be useful when water crisis occurs. II is also advisable because minimal use of water by people will help conserve water and ensure smooth supply in future. Both the courses will lead to

increase in the water level.

- 9. (b) Explanation: Since the act has been repeated despite various warnings, so course I would only be another warning and would not help. Severe punishment to set example for him and others is inevitable. Thus, course II shall follow.
- 10. (b) **Explanation:** The disease occurs at the end of monsoons every year. So, precautionary measures every four years shall not help. The second course of action shall be a preventive measure. So, only course II follows.
- 11. (b) **Explanation:** Clearly, the non-infected persons should not be debarred from visiting India. So, only course II follows.
- 12. (b) **Explanation:** The statement implies that capsule Vitamin E does not function so effectively as natural Vitamin E. Since no negative effect of capsule Vitamin E is mentioned, so I does not follow. Hence, only II follows.
- 13. (b) Explanation: Clearly, war is the last resort. First, peaceful talks and negotiations should be indulged in, to settle the issues of dispute. So, only course II follows.
- 14. (b) Explanation: Clearly, curtailing of the staff strength will only increase the panic and discontent, and the satisfaction of the employees is a must. So, the Government should arrange for payment of wages. Thus, only course II follows.
- 15. (c) **Explanation:** Clearly, either something should be done to alert the trains well in advance in case of a landslide or some means should be adopted to prevent blockage of tracks during landslides. Thus, either I or II follows.
- 16. (d) Explanation: Clearly, the library needs to be provided with the essential facilities and trained personnel for better services. So, both the courses follow.
- 17. (a) Explanation: Clearly, internet users should not





suffer on account of certain individuals who indulge in internet hacking. However, such wrong-doers ought to be penalised so that there are no hassles in the use of internet. So, only course I follows.

- 18. (a) **Explanation:** The police should at once be made cautious and put on high alert to prevent any untoward incident. Also, once caught, such criminals ought not to be released. They can be interrogated to detect other criminals. So, only I follows.
- 19. (d) Explanation: The failure of a majority of students hints at there being lackenings on the part of teaching faculty, which need to be pointed out and removed by constant efforts. So, none of the given courses of action follows.
- 20. (b) Explanation: Clearly, I is vague because if infected people are shifted to a non-infected area, the infection will spread there as well The remedy is only to fight the disease and restrict its spread. So, only II follows.
- 21. (a) Explanation: Clearly, internet users should not suffer on account of certain individuals who indulge in internet hacking. However, such wrong-doers ought to be penalised so that there are no hassles in the use of internet. So, only course I follows.
- 22. (d) **Explanation:** Crowding on footpaths is a great inconvenience for walkers. So, stern action needs to be taken to remove the vendors. But at the same time these people ought to be provided alternative means of livelihood. So, both the courses follow.
- 23. (c) Explanation: Clearly, either something should be done to alert the trains well in advance in case of a landslide or some means should be adopted to prevent blockage of tracks during landslides. Thus, either I or II follows.
- 24. (d) To avoid testing at the primary level admissions the government should take the course of action III.
- 25. (c) The best option in this case is to divert the load of vehicular traffic through various link roads during peak hours.
- 26. (b) The officer-in-charge of production should be suspended so as to ensure that this kind of a

- problem does not happen in future. Also the export order should be sold to the other party.
- 27. (d) If the entry of outsiders were stopped how would the victims get the help. Hence surely course of action (I) does not follow. Now if the civic administration is making alternate housing arrangements for the victim there is no requirement to shift them and viceversa. Hence II or III follow.

- 29. (c) Train drivers are not supposed to, nor able to stop trains in such situations, hence I is ruled out. Due to collision with running train, chances of bus driver's survival is negligible, hence II is ruled out. III gives a preventive measure for such mishaps.
- 30. (c) Statement I doesn't suggest a precautionary measure for future; which is there in II and III.
- 31. (b) Statement III puts all responsibility on fishermen alone. Watching a mishap is no cure for the mishap. Statement I is corrective measure and II is precautionary measure.

Now that the water is polluted, it has to be treated chemically before resuming supply, otherwise it may affect those using it. This also gives an example to Pollution Control Board to keep a check to prevent any mishappening at regular intervals.
